

SUMMARY ANNUAL REPORT

For SIMON PEARCE (US) INC. 401(K) PROFIT SHARING PLAN & TRUST

This is a summary of the annual report for SIMON PEARCE (US) INC. 401(K) PROFIT SHARING PLAN & TRUST, EIN 03-0278920, Plan No. 001, for period January 01, 2019 through December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$1,406,232. These expenses included \$51,794 in administrative expenses, \$1,313,326 in benefits paid to participants and beneficiaries, and \$41,112 in other expenses. A total of 315 persons were participants in or beneficiaries of the plan at the end of the plan year, although some of these persons may not yet have earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$11,795,943 as of December 31, 2019, compared to \$9,981,754 as of January 01, 2019. During the plan year the plan experienced an increase in its net assets of \$1,814,189. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plans assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$3,220,421, including employer contributions of \$168,374, employee contributions of \$794,200, earnings from investments of \$2,056,116, and other income of \$201,731.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (SIMON PEARCE US INC., 109 PARK ROAD, WINDSOR, VT 05089) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon
